# 1. Introduction

- 1.1 Dr. Moopen's College of Pharmacy is conducting D.Pharm, B.Pharm, Pharm.D. & M.Pharm (Pharmacy Practice)
- 1.2 Diploma in Pharmacy (D.Pharm) is a two year diploma course, Bachelor of Pharmacy (B.Pharm) is an under graduate course, Pharm.D (6 year). & M.Pharm (2 year) are post graduate courses which covers various aspects of Pharmaceutical Sciences.
- 1.3 This prospectus contains rules and regulations for selection and admission for the Academic Year 2025-2026
- 1.4 Admission is based on the order from Pharmacy Council of India, Govt of Kerala, Kerala University of Health Sciences and Admission Supervisory Committee.
- 1.5 The Conditions in this Prospectus is subject to modification/addition/deletion, as may be deemed necessary by the Management and will be subject to further orders, if any, passed by appropriate authorities/Courts of law.
- 1.6 Applicants are requested to go through the Prospectus carefully and familiarize themselves with all rele- vant information. They are also encouraged to visit the official Website of the College. i.e. www.dmwimspharmacycollege.com for more details.

# 2. Criteria for Eligibility and Selection

#### 2.1 Nationality

Applicants must be citizens of India. Children or dependents of non-residential Indians.

#### 2.2 Qualification

- a. D.Pharm, B.Pharm & Pharm.D: Candidates who have passed Higher Secondary Examination, Kerala or examinations recognized as equivalent thereto, with 50% marks in Biology/Mathematics separately and 50% marks in Physics, Chemistry and Biology/Mathematics put together are eligible. Candidates from National Open School are eligible to apply for the course.
  - M.Pharm: A candidate who was passed the B.Pharm degree examination from Kerala University of Health
  - Sciences or an examination equivalent thereto of any other University recognized by Kerala University of Health Sciences with not less than a total of 55% marks for B.Pham degree examination shall be eligible for admission to M.Pharm course. The candidate should have undergone B.Pharm degree in an institution approved by PCL

Applicant should possess certificate of good conduct and character from previous institution

#### 2.3 Age

Applicants for B.Pharm & Pharm.D. should have completed 17 years of age as on the 31 June 2025. No relaxation in the minimum age will be allowed.



# 3. How to apply

Application form are available in the website www.dmwimspharmacycollege.com. Students can submit the application through online only. Application fees Rs. 1250/- for B.Pharm & Rs. 1500/- for Pharm.D. & M.Pharm can be paid as DD in favour of DMERF, DM WIMS College of Pharmacy payable at SBI Kottapadi branch. ### 4. Admission Procedure

- 4.1. 50% of the total D.Pharm, B.Pharm & M.Pharm seats in the College will be filled up by the government from the list prepared by KEAM (B.Pharm & M.Pharm) and LBS (D.Pharm) in accordance with merit and reservation policies followed by government from time to time. Any lapsed seat will be filled up by the Management according to the instructions issued by the Competent Authority.
- 4.2 The remaining 50% of the D.Pharm, B.Pharm & M.Pharm seats shall be filled from management quota.
- 4.3 All Pharm.D. seats in the college will be filled from management quota.
- 4.4 Provisional Rank list will be published after varification of all eligible applications.
- 4.5 The students will be admitted the same day based on their ranks and thorough verification of documents In addition to the payment of prescribed fees.
- 4.6 Incomplete and incorrect application will not be considered.
- 4.7 The right of admission is reserved by the Principal
- 4.8 Fees once paid will not be refunded.
- 4.9 Selected applicants shall take admission at the appointed time and date in the college after paying the tuition fee and other fees, failing which the offer of admission will stand cancelled
- 4.10 The date of commencement of the course and the last date of admission process will be as per the time schedule fixed by the Pharmacy Council of India, Keral University of Health Sciences & Directorate of Medical Education

The selected applicants shall produce the following documents in original at the time of admission before the Principal, Dr. Moopen's College of Pharmacy:

- a. SSLC/10th Standard Certificate.
- b. Pass Certificate of the applicant at the qualifying examination
- c. Document (School Record viz: SSLC or equivalent) of the applicant to prove his/her date of birth.
- d. Eligibility equivalency certificate obtained from the Kerala University of

  Health Sciences by applicants who have passed the qualifying examination from
  boards other than the State of Kerala/CBSE/ISCE
- e. A physical Fitness Certificate obtained from a Medical Officer in Government Service not below the rank of Assistant Medical Officer.
- f. Course and conduct certificate from the institution last attended.
- g. Transfer certificate (TC) from the Institute last attended.
- h. Originals of other certificates, the copies of which are enclosed with the application form.
- i. Document/certificate required in proof of any reservation/benefit claimed in the application form.

Note: Applicants will not be given any extension of time to produce the original documents/ certificates and payment of fees. Two set of photocopies of all the self attested documents/ certificates listed above also has to be submitted at the time of admission.

### 5. Cancellation of Admission/Refund of Fees

- Annual tuition fees and other fees should be paid on or before 1st August of every year for 4 years. Late payments will attract penalty.
- Apart from the fees (Clause 6.1) students have to pay the actual cost related to all couses from B.Pharm course.
- Fees once paid cannot be refunded.

# 7. Rules & Regulations

The student's disciplinary policies and procedures emphasize the Dr. Moopen's College of Pharmacy obligation to promote personal freedom, maturity and responsibility of students.

- a. Candidate has to secure 80% of attendance for theory classes as well as practical in each subject for appearing the University Examination.
- b. The candidate must secure 50% marks in internal examination in each subject.
- c. The candidate must secure 50% marks in external examination separately in each theory and practical examination.
- d. Students should not break or damage any of the apparatus provided for their use.
- e. The student should groom professionally and well behaved in the college.
- f. Students are expected to abide by the rules and regulation framed and amended by the college from time to time.
- 9. Students are expected to maintain highest standards in their academic, professional and private life.
- h. Students must wear identity card whenever they are inside the college campus.
- i. No students should stand or loiter about in the corridors during class hours.
- J. Students are forbidden to write on walls, desks and other pleces of furniture.
- k. Certain undesired activities such as ragging, taking of alcohol and drugs, smoking, using vulgar language and indulge in violence are strictly prohibited.
- I. Students should give utmost importance to class work, practicals, home work and sessional examinations.
- m.No student will be admitted to the classroom unless he/she well equipped with the required instruments
  - and necessities as and when instructed by the concerned faculty members.
- n. Without prior permission of the Principal, the students should not organize/ conduct tours, picnics, cultural programmes etc.
- o. Students should not cause damage to any of the college properties like furniture, lab equipments etc.
- P. Using cell phone in the campus is not permitted.
- q. All students should strictly follow the dress code framed by the college. r. Boys should wear full trousers and full sleeve shirt tucked in with belt and black shoes.
- s. Students should wear the uniform in a neat and professional way.
- t. Students not adhering to dress code will not be permitted to attend the classes.
- u. Students will not be entertained in the college premises for any requirement without proper dress code during working hours.



- v Students must wear Uniform and White coat. (They must wear clean and washed Uniform. Unclean and unwashed Uniform will be the source of cross infection).
- w Hair should not be left loose, but should be well groomed, oiled and put up.
- x Shoes which cover toes are to be worn.
- y For Boys Shirt must be inserted and the first button of shirt must not be left open. Length of pants must be above heel.
- z For Boys Face must be neatly shaven and hair be groomed well, preferably oiled.

Any student found to violate any of the rules and regulations of the college or found disturbing the peace in campus as well as off campus will be punished by the Head of Institution, who reserves the right to suspend and/or dismiss the student without any prior explanation or notice.
